# Lifeguard: Outdoor Education Centre (Full Time)

### Job Purpose

As a summer camp, Sasamat Outdoor Centre prides itself on creating an engaging and supportive community where children are made to feel included in the camp culture. The supportive nature of the camp allows for campers to try new activities and develop new skills with the help of caring staff members. Sasamat's summer camp and Outdoor Centre is located in beautiful British Columbia. The Youth Roots After School program is designed to be a fun and educational after school experience, where participants can enjoy unique outdoor activities and challenge themselves with new experiences.

During Sasamat's spring and fall season's we operate as an outdoor education facility. Every week starting in late April until mid June and during our Fall season from September to the end of October, we have school groups come to our site for overnight and day trips where they participate in experiential learning programs using all of the outdoor activities at camp. The programs work by exposing participants to new skills and challenges where they are encourage to learn and grow, then reflect on their experience. Some activities include; canoeing, kayaking, climbing and high ropes, archery, nature and ecology programs, games, compass work, shelter and fire building and much more. We provide 5 days of training on all of our programs including professional site-specific ropes training so that our staff teams have the skills and tools to have a fun and successful work experience.

Our Outdoor Education season Lifeguard(s) provides the expertise, experience and skills required for the safety of participants while using Sasamat's waterfront and during water activities. Lifeguards will lifeguard swimmers and boaters on the water at all times. The waterfront lifeguard will also help OE program instructors with the facilitation of waterfront activities, including set-up, take down, cleaning/disinfecting, and instruction where needed. The waterfront lifeguard is an integral member of the program staff team and when there is no activity on the waterfront, the Waterfront lifeguard will be responsible for the cleaning and maintenance of waterfront, program materials, or assigned to assist elsewhere in camp.

Any skill or additional knowledge needed to operate in an outdoor center context or specific to our waterfront will be well covered during training before the start of the contract. Full time OE Lifeguard is guaranteed a minimum of 30 hours a week (although

### Staff Training

- Participate in 100% of staff training

### **Risk Management**

- Demonstrate knowledge of risk management protocols in keeping with camping industry best practices and provincial regulations
- Provide constant vigilance when on patrol
- Conduct a daily inspection of waterfront emergency equipment to ensure all is in place and good order
- Conduct a daily inspection of waterfront area to ensure it is free of hazards
- Promote safe COVID distancing and protocols
- Ensure that all program equipment as specified by the Summer Camp and Outdoor Education Centre Director is cleaned and disinfected per instruction
- Ensure Sasamat Outdoor Centre waterfront policies are being followed

### Camper Group Leadership

- Provide behaviour management and general camper care assistance whenever possible
- To provide group facilitation when needed, assisting program staff
- Role model appropriate behaviour
